July 18, 2023**

Dr. Slaton gave a brief update on all of the current projects under construction. SHS is still on schedule to be completed prior to the first day of school. Core will also be resealing and striping the parking lot. There has been a delay in some of the flooring for the weight room but that should be delivered within the next two weeks.  
ELA - The roof is completed with only the coping left to be done.
