Dr. Slaton shared a slideshow listing all of the available Dual Credit and AP classes that are available this school year. He was excited to share that over the course of 3 trimesters SHS will be providing 135 college credit courses for our students. He noted that the class of 2023 had 135 seniors with 104 (77%) of those earning college credit. A total of 1972 credits were earned meaning that of those 104 students, they averaged 19 college credit hours. Also Dr. Slaton shared that 67 students earned some type of industry or certification. He is very excited about the numerous opportunities at Scott District 2.

Mr. Brewster shared booklets with the board members that listed the district's updated coverage. It was recommended to change our cyber carrier from BCS/Evolve to Tokio Marine/Limit. This would be a premium savings of \$1,385. Also the district's Workers Compensation Modification Factor reduced from .98 to .90. After reviewing the data, Dr. Slaton and Mr Brewster were pleased with the renewal summary.
